### ANTI-SOCIAL AGGRESSION PLEDGE

I, (print name) \_\_\_\_\_, residing at (street and Apt. #) \_\_\_\_\_, Ludlow, MA 01056, agree that all areas of the Ludlow Housing Authority (LHA) should be free from Social Aggression, i.e., bullying, harassment, discrimination, hurtful gossip, etc, and that this behavior will not be tolerated.

If it is proven that I have taken part in any of these behaviors, I understand that I will be trespassed from the area at which the offense occurred and which is owned and operated by the Ludlow Housing Authority. Once I have been trespassed from the area where the incident occurred, then I may go to that area only to do what I need to do and will then promptly leave. If the aggressive behavior took place in the Community Room, then I understand that **I am not allowed to enter the Community Room for any reason.**

The length of time for trespass will be as follows:

- First Offense - a Verbal Warning conducted by LHA personnel
- Second Offense - a month of not being allowed to go into the area where the behavior occurred except to attend to necessary personal business and then leave the area
- Third Offense - one year of not being allowed into the area where the behavior occurred except to attend to necessary personal business and then leave

It is hereby understood that **any form of discrimination** will automatically cause me to be permanently trespassed from the area at the first offense. No further opportunities for offense will be allowed.

I also understand that there will be an opportunity for me to attend an anti-bullying session from Mass. Elder Affairs Protective Services. I will be notified of the date by post office mail once it is scheduled. The LHA will attempt to provide annual meetings, however once I have attended one of the meetings and I have committed no offenses. then I do not need to attend another meeting unless notified otherwise by the LHA. A new person (tenant or guest) just coming in may sign this form and must attend the next available annual meeting with the tenant who sponsored him/her.

I acknowledge that if I do not live in any of the Ludlow Housing Authority's rental units and that I am occasionally a guest of a tenant whose name is: \_\_\_\_\_

I must participate in one bullying meeting when it is scheduled. I will be notified of the meeting by the tenant listed in this paragraph. If it is proven that I have participated in discrimination against anyone participating in any activity or on the LHA's general property, then I will be asked to leave the premises. If I refuse to do so, not only will I receive a trespass order but I could be placing the privileges of the tenant who invited me in jeopardy.

For after-hours meetings or game-playing sessions, a list of those who are authorized to participate in activities will be posted on the bulletin board.
